



**SPECIFIC COOPERATION AGREEMENT FOR
STUDENT EXCHANGE BETWEEN**

**ALIANZA ESTRATÉGICA LIMA (PERU)
AND UNIVERSITY OF POITIERS**



La Alianza Estratégica de las Universidades Nacionales, Mayor de San Marcos, de Ingeniería y Agraria La Molina, represented by its President, Luis IZQUIERDO and University of Poitiers, represented by its President Jean-Pierre GESSON, agree to establish a student exchange program in accordance to the following terms:

FIRST CLAUSE: STUDENT EXCHANGE

- a) Every academic semester, both universities shall be able to exchange a previously agreed number of students under a reciprocity regime.
- b) The foreign students shall accept the compensated exchange modality. Under such a modality, the universities agree to send and receive an equivalent number of students within their respective academic semesters.
- c) The students participating in the exchange program shall formally register in their home university and pay their academic fees.
- d) The foreign students must be subject to the current regulation in the host university and they shall be able to join regular courses under the regime of the School of Special Studies or its equivalent in the host institution; this in agreement with the provisions from the office in charge of the students exchange in each institution.
- e) The office in charge of the students exchange in the host university provides academic advice to the students and facilitates the search of adequate student housing. Like the students have access to all the services university usually provides to the regular students.
- f) Travel expenses from the city where the home university is located to the city of the host university shall be fully paid by the student. Likewise, the student shall pay transportation expenses, medical insurance and any other expense that may arise during the exchange period.
- g) The host university shall issue transcript with the grades obtained by the student. The home university based on its internal standards shall acknowledge such certificates.

SECOND CLAUSE: OFFICE IN CHARGE

The exchange program shall be managed through the Area of International The Relations of Universidad Nacional Mayor de San Marcos of Peru and its equivalent at University of Poitiers.

THIRD CLAUSE: VALIDITY OF THE AGREEMENT

The agreement herein shall have a validity of five years as from the subscription date. Such a term may be renewed if both parties expressly agree to do so in writing 90 days before its expiration date.

Likewise, either party shall be able to terminate the agreement herein through a written communication sent to the other party, at least 30 days in advance, without affecting the activities already started or being developed.

In agreement of the above, the parties subscribe the agreement herein in four copies, on day of 24th january 2009.
